Sample License for Windows LAN versions:

Professional Development Software (PDS) Inc. grants to the purchaser of this agreement a license that allows nursing students and faculty associated with one campus of one school of nursing unlimited on-site use of the licensed title(s), on any number of individual machines or in-house local area networks. The access does not extend to students and faculty associated with any other campuses, even those that may be secondary sites of the same nursing education program and have access to the same wide-area network (except by special arrangement). This license does not include title upgrades (if released) free of charge. Title upgrades (if released) will be available to owners of most recent versions at reduced rates.

Sample License for Internet versions (one school access code):

1. SOFTWARE LICENSE. Subject to the terms of this Agreement, PDS hereby grants to Licensee a limited, nonexclusive and nontransferable license for its Users to use the Website and/or Application and any associated Documentation solely as set forth below and in accordance with such Documentation. An "Application" is the object-code version of the applicable PDS software modules licensed pursuant this Agreement, including, without limitation, the PDS software available through this website. A "User" is a student at a school of nursing Licensee, a faculty member at a school of nursing Licensee, or a nurse employed at a healthcare organization Licensee, as the case may be, as described below. The number of Users for an Application will be established at the time of the license grant based on the license fees paid. Licensee may only create and use the number of applicable User accounts for which it pays license fees and receives product authorization codes from PDS with respect to its use of the Application. "Documentation" means the user, administrator and technical manuals, electronic or otherwise, pertaining to a Module and any other information relating to the Applications provided to Licensee by PDS in any manner, including, without limitation, through the Website, via e-mail, or otherwise.

4. **LIMITED WARRANTIES AND DISCLAIMERS.** PDS represents and warrants for thirty (30) days from the Effective Date, that the Software will operate substantially in accordance with the applicable Documentation, provided that Licensee operates the Software in compliance with such Documentation. In the event the Software fails to satisfy the warranty immediately above, PDS will, at its option, correct or replace the nonconforming portion of the Software in a timely manner and will otherwise provide the Support Services for such Software as set forth herein. The limited warranty set forth herein will not apply to nonconformities determined by PDS to have been caused by (a) deletions or modifications to the Software performed by a party other than PDS, (b) negligence in the operation or use of the Software, or (c) use, adjustments, installation, or malfunction of any products or goods other than those authorized by PDS. The limited warranties set forth in this Agreement are made for Licensee's benefit only. The remedies set forth above are the sole and exclusive remedies for breach of these limited warranties. This Agreement shall be deemed severable.
